## Terms of Participation for the "Best picture of Geomash Drill rig in action" Photo Competition

- 1. Photo Competition As part of this photo competition, Geomash Group is looking for the most impressive images of our drill rigs in action. Our judging panel will select the winners from the best entries. Participation in the photo competition and its implementation is subject to the following conditions.
- 2. Organizer The organizer of the photo competition is Geomash-Center LLC Russia, Moscow, Kuntsevskaya st. 9/2.
- 3. Eligibility Persons who have reached the age of 18 at the time of participation are entitled to participate. The participant of the photo competition is the person, or an authorized representative, who submits a photo for the competition him/herself either by sending it to our email address geomash-centre@yandex.ru or sending it by post. Participation is not restricted to the organizer's customers and it is not contingent on the purchase of a particular product or service.
- 4. Entry Period The entry periods for the "Picture of the Month" photo competition run from 23.03, 00:00 until 30.04, 11:59 pm. All of the photos that are submitted will be assessed for the entry period in which they are received by the organizer. The winners will then be determined the following month. The winners will be selected from all of the participants in the photo competition, who have consented to their participation within the competition period and are entitled to participate. An internal judging panel will select the winners from the best three photos.
- 5. Winners Notification of the winners will be sent by e-mail exclusively to the participant who submitted the photo. The entitlement to the prize shall expire if the winner is unavailable, if there is a lack of acknowledgment or if the prize is not accepted after the end of one month, calculated from the date the winner was first publicized.
- 6. Prize The prize for the winning participant is EUR 100.00, the second prize is EUR 80.00 and the third prize is EUR 50.00.
- 7. Image Rights By uploading a photo, each participant declares to hold all existing rights to the photo he/she is uploading and that he/she consents to the publication of the photo along with his/her personal details. In addition, the Geomash-Center LLC shall be granted the rights to carry out editing (especially electronic image processing in the case of online appearances), duplication and reproduction by means of image carrier as well as the right to transfer these rights to third parties. The aforementioned transfer of the rights of use shall be free of charge. Each participant warrants that no rights of third parties will be infringed by the publication of their photo. This particularly covers third party copyrights and personal rights of the persons photographed. The participant shall release Geomash-Center LLC from any claims by third parties arising from the infringement of such rights and the costs of prosecution. There shall be no right to participation in the competition and to the publication of photos that have been submitted. By participating, the participant agrees to the rules of the photo competition.
